I GENERAL TERMS

The company does not guaranty/assure any facilitation fee or income to the direct seller or account of becoming just a mere "Direct seller" of the company.
- iii) Track id has to be quoted by the direct seller and all his/her transaction and correspondence with the company. The track id chosen can't be altered at any point of time.
- iv) No communication will be entertained without unique ID and password. Direct seller shall preserve the ID and Password properly as it is "most" for logging on to website or android app.
- v) Commission/income to the direct seller shall be subjected to statutory deduction as applicable.
- vi) The company reserve its right to withheld/block/suspend the direct seller in the event the direct seller fails to provide any details as desired by the company from time to time including but not limited to pan card details.
- vii) Processing charge and any other applicable charge will be deducted as per the company norms.
- viii) Direct seller undertakes to adhere for policies, procedure, Rules and regulation formed by the company. The direct seller shall be faithful to the company and shall uphold the integrity and decorum to the company and shall maintain good relations with other direct seller and other clients also.
- ix) Company reserves the right to modify the term and conditions, products, plan, business and polices with/without giving prior notice. Such notice may be published through the official website of the company and any such modification/amendment shall be applicable and binding unto the direct seller from the date of such notice.
- x) In case of death or loss of contractual capacity of direct seller, his/her nominee or legal heir shall become the direct seller of the company and he/she shall also abide by all rules and regulation, terms and condition etc. in the same manner as original direct seller was being abide/supposed to abide.
- xi) Direct seller shall company with all state and central government and local governing body laws, regulation and codes that apply to the operation of their YOUTH ECHO REVOLUTION PRIVATE LIMITED Business. Direct seller most not engage in any deceptive of unlawful trade practice as defined by any central, state, local laws or regulation.
- xii) Direct seller shall not manipulate the youth echo revolution private limited. Marketing plan or product's rate. B.V. etc in any way.
- xiii) Direct seller shall not send, transmit or otherwise communicate any message to anybody on behalf of company otherwise than for authorization for the same.
- xiv) Direct seller or any other person is strictly prohibited to use business promotional material other than business promotional material developed and/authorized to develop by the company.
- xv) Direct seller shall not use the youth echo revolution private limited trademark, logo type and design anywhere without written permission from the company. This permission can be withdrawn at any time by the company.
- xvi) All the arrangements, expenses, permission from local authorities, complying with rule of central and state government and local body is whole responsibility of direct seller for meeting and seminars conducted by direct seller

(a) Direct seller is personally liable to pay service tax applicable as per rule.

2) PROHIBITION

- i) Direct seller or his/her relatives (relative means dependent son or daughter, father/mother, spouse) shall not engage in any activity of multi level marketing of any other entity. If it is found than such direct seller be terminated.
- ii) Direct seller is prohibited from listing, marking, advertising, promoting, discussing or selling any product or the business opportunity on any website or online forum that offers like auction as a mode of selling.
- iii) The direct seller hereby undertakes not to compel or induce or mislead any person with any false statement/promises to purchase from the company or to become direct seller of the company.
- iv) The direct seller needs to be above 18 year of age.
- (1) The direct seller shall not have more than one unique ID on same aadhar no. if found shall be canceled without prior intimation.

3) DUTY AND CONFIDENTIALLY

- Parties shall
- i) Keep confidential information secret and confidential and not disclose any of it to any person other than person who reasonably needs to know the same for the purpose.

4) SPECIAL CONDITIONS

Not with standing anything stated or provided herein, the company shall have full power and discretion to modify, after or very the term and conditions in any manner whatsoever they think it and shall be communicated through official website of other mode as the company may deem fit and proper by giving a written notice to the company. Without submission of the objection for modification etc. if direct selling activities then it will be deemed that he/she has accepted all modification and amendment in the term and conditions for future.

5) Termination

- v) Information given by direct seller found wrong/false,
- vi) In convicted of an offence punishable by a prison term,
- vii) Is declaring bankrupt?
- viii) Is not mentally sound to handle the business,

6) Force majeure

The company shall not be liable for failure to perform its obligation where such failure has resulted due to act of nature (including fire, flood, earthquake, storm, hurricane, or other natural disaster) war invasion, act of foreign enemies, hostilities (weather war is declared of not), civil war, rebellion, revolution, insurrection military or usurped power or confiscation terrorist activity government (central/state) and local authority etc.

7) Recourse and legal applicability

- i) The term and conditions stipulated in the forgoing paragraph shall be governed in accordance with the law in force, force in India, disputes, if any, shall be subjected to the exclusive jurisdiction of the court in Ranchi Jharkhand.
- ii) If any disputes or different arises out of or in relation or these presents the same shall be referred to sole arbitrator appointed by the company. Direct seller shall not raise any objection, in case the arbitrator so appointed by the company is related/associated with the company in any manner whatsoever. Arbitration in such event shall be conducted as per "Arbitration and conciliation act 1996" as amended from time to time. Venue of such arbitration shall be in Gumla and the language shall be English.
- iii) Youth echo revolution private limited's liability whether in contract, tort or otherwise arising out of or in connection with the agreement and relationship arising there form shall not exceed the lesser of
a) actual damages or los assessed by the arbitration of any other dispute resolution mechanism adopt by the parties or
b) The total commission earned by the direct seller during preceding six month of the date of dispute.
